

OTHER USEFUL INFORMATION

1. **Directions to Sheraton Parsippany Hotel** : This fabulous hotel is located in Parsippany, NJ near the intersection of I-80 and I-287 and approximately 25 miles from Manhattan (or 30 miles from Time Square) and 25 miles from the Newark Liberty International Airport. 2. **Airports**: You can fly into Newark, La Guardia, JFK, Stewart or White Plains or Philadelphia. However, Newark Liberty International is the most convenient airport to the hotel. All have limo service that the Sheraton can refer you to.
3. **Transportation from Newark Airport**: you can rent a car, take a limo service, take a shuttle service or take a taxi:

The number of **activities** in the New York Metropolitan area are unlimited from fine dining, museums, parks, Statue of Liberty, Ellis Island, Harriman Park, Catskill Mountains, Broadway shows, Empire State Building, Rockefeller's Kykuit mansion in Sleepy Hollow, people watching in Manhattan, etc. etc. etc. Please make your own plans. By the way, Philadelphia is also accessible.
5. The **Argentine asado** will include chorizos, empanadas, other typical cuts of meats, chicken, hot dogs, hamburgers, alfajores, etc. Please note that beer and Argentine wine will on a cash bar basis in order to keep the costs reasonable and fair for all.
6. **Germania Park** (asado site) is located in Dover, NJ (15 minutes from the hotel) that has a covered pavilion, soccer field and 7 acres of woods.
